Notice is hereby given:

A. That an election will be held for the filling of the following offices:

B. That an election will be held for the election of a Senate nominee for the purposes of the *Alberta Senate Election Act*.

C. That a vote of the electors will be held on the following referendum question(s) under the *Referendum Act*.

- Should section 36(2) of the Constitution Act, 1982 – Parliament and the government of Canada's commitment to the principle of making equalization payments – be removed from the constitution?
- Do you want Alberta to adopt year-round Daylight Saving Time, which is summer hours, eliminating the need to change our clocks twice a year?

VOTER IDENTIFICATION REQUIREMENTS

In order to vote, you must produce identification for inspection. The identification must be one or more of:

- Identification issued by a Canadian government (federal, provincial or local) which contains a photograph of the elector and their name and address; or
- Identification authorized by the Chief Electoral Officer under the Election Act to establish an elector's name and current address.

As required by section 53 of the *Local Authorities Election Act*.
