Rene Rajotte agreed with the concerns of the written submissions and would like to see some environmental studies completed and some direction set with regard to development around the lake. Tammy Goulet advised that the subdivision that Dwayne and she have applied for will add no pressure on the lake and is a subdivision for them to leave to their children. Noreen Herbert requested to know how it would affect the tax base. Gordon Miniely advised the Goulets that they were good neighbors and this was not personal, but he had concerns along with all the property owners around the lake with regard to the history of the density around the lake. He has concerns with the quality around the lake and trusted that the M.D. knows that they need to develop a plan for development around the lake, with regard to these developments. Scott Herrington asked the question if there was a Plan? What is the Plan? What is the big picture? Reeve Barss advised the group that the MPC

handles a development request and if all conditions are met the subdivision is approved. Noting that the M.D. must consider developing a subdivision plan for the surrounding area around Clear Lake and judging by the group that is here today consider doing a impact study, environmental study and public input consultations prior to developing a plan. Dwayne Goulet stated that he does not believe that 1 house will impact Clear Lake but feels the problem lies with the 100 people coming in on the weekends to the public beach, noting they stir up a lot more activity then one subdivision. Gordon Miniely noted that he is not arguing against the Goulet development but the future that he is concerned about and the implications that subdivisions around the lake bring. Dwayne Goulet noted that it is the cabin sizes that are changing that are causing the increase in traffic. Gordon Miniely informed him that they follow the rules with regards to cabins on the lake noting they can only replace old ones. Daisy Chesterman opposed the subdivision noting that the house is up for sale. Reeve Barss advised her that this has nothing to do with this public hearing. Roger Holmes requested clarification with regard to the application and if requirements are met what other options does Council have but to approve it. Reeve Barss and Administrator Kelly Buchinski advised that if conditions are met and there is no legal issue holding the subdivision back, it and Council declines the subdivision, the applicant would have the right to appeal it. If all rules and regulations are met the subdivision should go through. Roger Holmes does Council have the ability to defer the subdivision? Administrator Kelly Buchinski advised there are time limits to follow and Development Officer Norma Schiefer advised that subdivisions go to the Municipal Planning Authority for approval. Roger Holmes wondered if there is no point of law to deny the subdivision what is the point of a public hearing? Development Officer Norma Schiefer advised that the public hearing concerns are taken into consideration but if all rules and regulations are followed and the MPC denies the application the applicant has the right to appeal. Scott Herrington stated he would like to be pro active for the lake and suggested getting a better master plan in place. Reeve Barss agreed that it is time for public input and a development plan. Scott Herrington asked if he should start a petition? Dwayne Goulet assured the group that his development would not address the issues they were discussing. Randy MacKenzie advised the group that his family has owned lake land for years and has no oppositions to this subdivision and noted that the problems are weekend riders not building a house on the land. l ee Herbert noted that he had traffic concerns. Addie Coleman advised that he has been watching the lake grow since 1932 and wondered if the Department of Environment had a study stating that only 75 cabins were to be allowed on the lake not 134? Development Officer Norma Schiefer advised she did not know of any study but would contact Alberta Environment. Addie Coleman also asked it there were grounds to shelve this issue?
